77th Independence Day Celebration

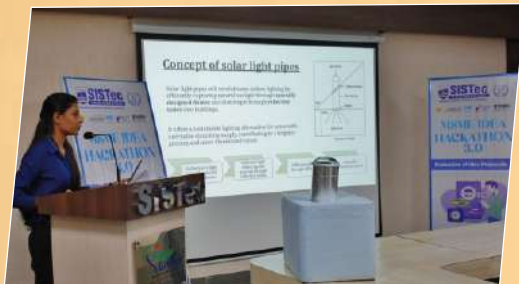

MSME Idea Hackathon 3.0

SISTec conducted the MSME Hackathon 3.0 for the women entrepreneurs at its campus. The hackathon went on for an almost 65-day selection process, in which more than 24 budding women entrepreneurs presented their business proposals, which were critically evaluated by experts from different domains for possible funding of ₹15 lakhs. The Hackathon was organized under the aegis of the Ministry of Micro, Small, and Medium Enterprises (MSME) at SISTec which is one of the few Host Institutes for the implementation of the incubation component under the MSME Innovation Scheme.
